This course also covers ethical issues faced in the construction industry.

- 3. determine the concept and features of contract management,

- 5. describe the types of contractual arrangements frequently used in the construction industry,
- 6. determine the purchasing procedures and project delivery systems used in the construction industry,
- 7. determine the main methods and procedures used in the conflict management and dispute resolution process.
